On 06/20/10, Hernando County Deputies responded to Ayers Rd & Culbreath, Brooksville reference to a report of a male and a female who were injured.

The male victim identified as ENRIQUE DANIEL ACEVEDO, DOB 09/22/91, of 10155 Gifford Dr, Spring Hill had been stabbed and succumbed to his injuries at the scene.

The female victim identified as Skyler Nicholle Collins, DOB 03/27/92, of 10423 Cheever Rd, Brooksville, FL had been strangled but did survive. She was transported to a local hospital for treatment.

The female victim, Collins vehicle's, a 2001 Ford Mustang, red in color with a tan convertible top, with Florida tag 272MGM was located at approximately 7:24 am this morning. The vehicle was found abandoned at Fairbanks and Hallcrest Ave, in Spring Hill.

One suspect has been arrested and is identified as SHERRIE DICUS, W/F, DOB 01/22/72, no address-transient. She was located in a wooded area off Christie Lane in Spring Hill on 06/21/10 at approximately 1:00 am and was taken into custody.

Suspects we are currently attempting to locate are identified as:

- (1) STEVEN A. WESOLEK aka: STEVEN MATHIS, W/M, DOB 09/08/90, 5'7", 128 LBS, blonde hair, blue eyes, no address.
- (2) SABRINA DICUS, W/F, DOB 08/12/95, 5' 10", 160 lbs, brown hair, no address.

Both suspects are wanted in connection with the Homicide, Attempted Murder and Carjacking. If anyone knows the whereabouts of the suspect, call 911 immediately.
