**Re:** Search Warrants Net 10 Arrests on Hanover Ct-Spring Hill

On Friday, February 25, 2011, search warrants were served at three residences in Spring Hill. Due to the anticipated amount of suspects at the residences, members of the SWAT Team made the initial entries into the homes while the helicopter and K-9 team stood by in case suspects attempted to escape.

A total of ten (10) suspects were arrested, and one suspect, Timothy Smiley (B/M, 04/12/70) has a warrant outstanding for his arrest. Below is a listing by address of the items found and the suspects arrested at each location.

1256 Hanover Court (HCSO case #2011-06642)

- 5.1 grams of Marijuana
- 1. Collins Smiley (B/M, 08/14/89) – Trafficking in Oxycodone (warrant case #2011-05078 ), Sale and Possession of Crack Cocaine (warrant case #2011-05536 ), bond \$90,000
- 2. Kendrick Smiley (B/M, 02/20/92) – Possession of Marijuana under 20 grams, bond \$500

  2. Keltwon Newberry (B/M, 01/26/87) – Sale and Possession of Oxycodone, Sale and Possession of Alprazolam (warrant case #2010-06532), bond \$20,000
  3. Evan Dubman (W/M, 05/04/89) – Sale and Possession of Crack Cocaine, Unlawful Use of 2-way Communication Device (warrant case #2011-04675), Sale and Possession of Crack Cocaine, Unlawful Use of 2-way Communication Device (warrant case #2011-04792), bond \$90,000

Sheriff Al Nienhuis was at the scene of the three search warrants this morning. Sheriff Nienhuis wanted to assure the neighbors “my deputies will continue to be out in full force in a continued effort to give you back your once safe and orderly neighborhood”.

A warrant has been issued for Timothy Smiley (B/M, 04/12/70) for Possession of Crack Cocaine with Intent to Distribute, Possession of Cocaine with Intent to Distribute, Possession of Marijuana over 20 grams, and Possession of Drug Paraphernalia.
