Re: Vice and Narcotics Conducts Two Separate Operations Which Results in Four Arrests

Date: June 30, 2011

Case#: 2011-19381, 2011-00449, 2011-20942, 2011-21757, and 2011-21775

On Wednesday, June 29, 2011, Vice and Narcotics conducted two separate operations which resulted in 4 arrests.

After a six month long investigation two wanted subjects were located on the morning of 06-29-2011 at the Budget Inn, 1795 E. Jefferson Street, in District 3. A search of the hotel room resulted in the seizure of the following items:

- One Rossi .357 caliber revolver
- 1.8 grams of Marijuana
- 10 Oxycodone tablets
- 6 Suboxone tablets
- 1 gram of Hashish
- Assorted Drug Paraphernalia (baggies, grinder, rolling papers, etc.)

The following is a list of the subjects at the hotel and their charges:

Chad Glover (w/m, 09/02/84)

- Warrant (case #2011-19381), Sale and Possession of Cocaine, Sale and Possession of Oxycodone, Unlawful Use of 2-way Communication Device, Possession of Drug Paraphernalia
- Warrant (case #2011-00449), Principal to Sale of Marijuana, Unlawful Use of 2-way Communication Device
- Warrant (case #2011-20942), Sale and Possession of Cocaine, Unlawful Use of 2-way Communication Device, Possession of Drug Paraphernalia
- PC Arrest (case #2011-21757), Possession of Firearm by Felon, Possession of Oxycodone, Possession of Hashish, Possession of Marijuana under 20 grams, Possession of Schedule V Narcotic (Suboxone), Possession of Drug Paraphernalia

- Subject was given No Bond due to being on Felony Drug Probation

Brandi Pitts (w/f, 07/02/86)

- Warrant (case #2011-19381), Principal to the Sale of Cocaine, Principal to the Sale of Oxycodone, Person in Possession of a Conveyance Used for Sale of Narcotics
- PC Arrest (case #2011-21757), Possession of Marijuana under 20 grams, Possession of Drug Paraphernalia
- Total bond \$31,000

On Wednesday June 29, 2011, the Hernando County Sheriff's Vice and Narcotics section executed a search warrant at 4345 Candler Avenue (case #2011-21775) after a one month long investigation. The investigation resulted in the seizure of the following items that were located within the residence:

- 547.6 grams of Marijuana in assorted baggies with different "brand names" of Marijuana on the bags
- One Cobra .45 caliber semiautomatic handgun
- \$2000 in U.S. currency
- Numerous items of Drug Paraphernalia (scales, baggies, rolling papers, etc)

Upon serving the search warrant, contact was made with Thomas Santana (w/m, 11/22/77) and Andrea Stone (w/f, 11/01/78) who both resided at the residence. Both subjects were taken into custody and charged with the following:

Thomas Santana

- Possession of Marijuana with Intent to Distribute
- Possession of Drug Paraphernalia
- Total Bond \$10,500

Andrea Stone

- Possession of Marijuana under 20 grams
- Possession of Drug Paraphernalia
- Given Notice To Appear

There were three children located at this residence. The Department of Children and Families was called to the scene due to the Marijuana being easily accessible to the children. This part of the investigation is ongoing.
