On September 8, 2011, the Hernando County Sheriff's Office conducted two search warrants resulting in the arrest of 4 suspects and charges pending on two additional suspects.

The first search warrant was served at **2115 Founder Road** in Spring Hill, case #2011-29999. The only items located of evidentiary value were 1.3 grams of Marijuana along with drug

paraphernalia. The two suspects from this residence who had warrants were not located. The first suspect is **Jessica Siciliano** (w/f, 05/12/93) who is currently in JDC custody. A hold has been placed on her for three warrants, which include Principle to Sale of Crack Cocaine. **Zachery Bowles** (b/m, 06/30/93) was also not present at the residence during the search warrant. Bowles currently has four warrants for Sale/Possession of Crack Cocaine and Sale/Possession of Marijuana.

The second search warrant was served at **19350 Fenwick Road** in Brooksville, case #2011-30000. The following items were located at the residence:

- 26.5 grams of Crack Cocaine packaged for sale
- 3.1 grams of Marijuana
- Several items of Drug Paraphernalia
- \$3722 in U.S. currency
- 53 rounds of assorted ammunition (.45, .22, and 20 gauge)
