#### UPDATE

The first shooting victim located at 3404 Olson Road in Spring Hill has been identified as **James Rufus Elswick, W/M DOB/09-06-1960**. Elswick died as a result of his injuries.

The second shooting victim located at 2993 Commercial Way in Spring Hill has been identified as **Richard Webb Jr., W/M DOB/10-27-1982**. Webb, who remains hospitalized, is expected to make a full recovery.

#### Original Information

The Hernando County Sheriff Office has released the name of the man responsible for two shootings Thursday afternoon in Spring Hill.

The incidents involving **Theodore Antonia Parker, W/M DOB/07-22-1958**, started around 2:36 p.m. at a residence on Chestnut Drive in Hudson.

During that encounter, Parker entered a residence a fired several shots at a female victim.

While it didn't appear the woman was hit by any bullets, investigators say he physically battered the victim causing serious, but non-life-threatening injuries.

Parker then drove to a residence on Olson Road in Spring Hill.

At around 2:43 p.m., Parker proceeded to shoot a male victim at that location. That victim died as a result of his injuries.

Parker then drove to the Smokes Smoke and Vapor Shop located at 2993 Commercial Way, Spring Hill, where investigators believed he attempted to rob the business armed with a firearm.

During the encounter Parker and a smoke shop employee exchanged gunfire.

Both Parker and the employee struck each other with gunfire.

Both individuals were transported by ambulance from the scene. Parker was pronounced dead by the medical staff at the hospital. The smoke shop employee remains in critical condition.

The investigation remains active. There are no additional details at this time.

**The Office of Sheriff:**
