**Re:** District Two Detectives Bust Juvenile Burglary Ring

During the month of November, an increased number of burglaries were noted in District Two. Many of the burglaries being reported were to vehicle and to garages with the items targeted being money, tobacco, alcohol, and/or bicycles.

District Two detectives developed an Operational Plan in an attempt to suppress the crimes and/or obtain leads to solve the open cases.

While conducting the Operational Plan, investigative information was obtained that Nicholae Allcock (AKA Nikko) and Brandon Rozenburgh were possibly responsible for the crimes. The detectives immediately followed up on the lead.

On 12-03-13, Detective Rocky Howard and Detective David Vargas located Allcock and Rozenburgh. The detectives were able to determine that both suspects, along with one other person, Austyn Urban, were responsible for the burglaries.

Investigation revealed that the group would not all go out at one time. Instead, on one night Allcock and Rozenburgh would go out. The next time, Rozenburgh and Urban would go out, and then Urban and Allcock would go out together. One would enter a car or a garage, and the other would act as the "lookout."

Sheriff Nienhuis said, "Criminals, especially those who commit multiple crimes, just do not seem to understand that it only takes one small lead to put them behind bars. Therefore, no matter how smart they think they are, they will eventually run out of luck and be caught. This is especially true when you have seasoned detectives, who track criminals for a living, hot on their trail."

The investigation cleared the following ten burglaries in District Two:

  - o Burglary Dwelling – 4 Counts
  - o Burglary Conveyance – 1 Count.
