**SITUATION**

A debris assessment has been completed by Hernando County's debris removal contractor. Please see below for information on debris removal from areas impacted by Hurricane Hermine.

**DEBRIS REMOVAL**

Hernando County is beginning its recovery process in the wake of Hurricane Hermine. Residents are asked to place any storm-generated debris on the public right-of-way. Debris collection will begin **early tomorrow morning, Tuesday, September 6, 2016**. Per our debris contractor, please set out debris for the first pass no later than **Monday, September 12, 2016**.

The public right-of-way is the area of residential property that extends from the street to the sidewalk, ditch, utility pole, or easement. Do not place debris on the roadway. Keep vegetative debris (woody burnable debris such as limbs and shrubbery) separated from construction and demolition debris, and white goods (refrigerators, washers, dryers) as they will be collected separately. Bagged debris should not be placed on the public right-of-way; only loose debris will be collected.

Do not place near water meter, fire hydrant or any other aboveground utility. Only debris placed on the public right-of-way will be eligible for collection until further notice.

If all debris is not picked up during the initial pass, please continue to push remaining debris to the right-of-way for collection on subsequent passes. Household garbage will be collected by your normal service provider on usual collection dates.


