Re: Traffic Stop Leads to Arrests and Several Felony Case Closures

Date: May 15, 2017

On 05-12-17, Deputy Corey Zarcone conducted a traffic stop on a red Dodge Neon for a routine traffic infraction.

Upon making contact with the two occupants in the vehicle, Deputy Zarcone identified one of the male occupants as Nicholas C. Sereda and the other as Randall W. Englehardt. Coincidentally, Deputy Zarcone had civil papers in his patrol vehicle that needed to be served on Sereda.

While utilizing in-house computer programs to verify the civil paperwork, Deputy Zarcone observed that both males were listed as suspects in open felony cases in District One. While still roadside, on the traffic stop, Deputy Zarcone contacted the case agent, Detective L. Genovese by phone. Genovese's partner, Detective L. Phelan, was close by and responded to the scene of the traffic stop.

After obtaining consent to search the vehicle, Detective Phelan located property (inside the vehicle) that he believed was related to and stolen from an open burglary case. After confirming the property was in fact stolen, Sereda was placed under arrest and transported to the Hernando County Detention Center. Sereda was extremely uncooperative with the investigation.

Later in the evening, Detective Phelan followed up with Englehardt, who was located at a friend's house. Phelan interviewed Englehardt and obtained confessions from him regarding Englehardt's involvement as well as Sereda's involvement in several cases. Englehardt advised Detective Phelan that he and Sereda were responsible for the following crimes:

- Grand Theft Auto of a 2003 Kawasaki 4-wheeler stolen from Lake Lindsey Road
- Burglary to a Structure at Englehardt's grandparents' house on Daleo Lane
- Grand Theft of jewelry from Sereda's mother's house on Chicaric Road

- Burglary to a Structure at Sereda's grandmother's house on Chicaric Road.

It should be noted that Englehardt was cooperative with the investigation.

Detective Wayne Peterson and Detective L. Genovese both responded to assist with the investigation.

Detectives recovered several items of stolen property and will be able to return said items to their respective owners.

Both suspects were arrested and charged as follows:
