Re: Drug Search Warrant Leads to Five Arrests in Spring Hill

Date: August 10, 2017

On 08-09-17, detectives with the Hernando County Sheriff's Office Vice and Narcotics Unit executed a narcotics search warrant at 9553 Bayside Court, Spring Hill.

The search warrant and arrest warrants are a result of a lengthy investigation that took place at the Bayside Court location after detectives received complaints of drug activity at the residence.

During the investigation, undercover detectives took part in narcotics transactions where several subjects to include the resident, **Nicole Marino W/F DOB/o6-o8-84**, sold methamphetamine and prescription pills from the residence.

This residence has been the focus of many investigations and has been deemed a nuisance by deputies. In the last year, deputies have responded to the residence over 40 times for various calls. Those calls included disturbances (verbal, physical and weapons), home invasions, recovered stolen vehicles, narcotics, and the location of several wanted subjects.

As a result of the search warrant, detectives located prescription medication and a large amount of hypodermic syringes, along with paraphernalia consistent with methamphetamine use.

Many citizens in the neighborhood made it a point to express their gratitude for the execution of the search warrant.

In total, five subjects were arrested and their charges are below:
