Re: UPDATE - Stolen Vehicle - Escaped Prisoner - Hernando County Northwest

Solid Waste Management Facility - Landfill

Date: August 16, 2017

Update

On o8-16-17 at approximately 6 p.m., Hernando County deputies were dispatched to Parsons Road in Brooksville regarding a Stolen Vehicle complaint.

The caller advised his vehicle had been stolen "within the last five minutes."

Deputies, still in the area searching for the escaped inmate, immediately began attempting to locate the stolen vehicle.

It is believed the escaped inmate stole the vehicle and fled the area.

The stolen vehicle is described as a 1971 Chevrolet C10 pickup truck, blue in color (photo attached). The Florida tag assigned to the vehicle is ECYD59. The tag was on the vehicle when stolen. The truck may have damage from crashing through a fence on the owner's property.



Original Information

On o8-16-17 at 12:21 p.m., Hernando County deputies were dispatched to the Northwest Solid Waste Management Facility (landfill) located on Norris Bishop Loop regarding an Escaped Prisoner.

Investigation revealed that inmate, **Joshua Holmes W/M DOB/12-13-1981**, who was assigned a work detail at the landfill, left the facility without authorization.

Holmes and two other inmates were working under the supervision of Hernando County landfill employees at the time of the occurrence.

The description of the Escaped Prisoner, Joshua Holmes, is as follows:

- White Male
- Height 5'7"
- Weight 145
- Hair Balding (brown on sides)
- Eves Brown
- Clothing White and black striped two-piece inmate clothing or brown boxer shorts.

Holmes' original charges - VOP Grand Theft Auto.
