Re: Update: Buy/Bust Operation Leads to Four Arrests

Date: October 12, 2017

UPDATE:

William Glover, B/M DOB/1-22-93, was recently sentenced to a two-years with the Florida Department of Corrections for the Sale and Possession of Marijuana and the Unlawful Use of a Two-Way Communication Device.

Original Information:

On 02/09/17, detectives with the Hernando County Sheriff's Office Vice and Narcotics Unit, with the assistance of the K9-Unit, conducted a Buy/Bust operation in the parking lot of the Chevron Fast Lane Express gas station located at 13045 Spring Hill Dr., in Spring Hill.

At approximately 4 p.m., William Glover, B/M DOB/1-22-93, arrived with Ashley Roller, W/F DOB/1-29-94, at which time Glover met with an undercover detective to conduct a narcotics transaction. Before the transaction, Glover met with a vehicle occupied by Sammi Jo Martinez, W/F DOB/5-19-90, and Nicholas Bailey, W/M DOB/6-12-92, at which time Glover picked up a bag of marijuana which he then delivered to the undercover detective.

After the transaction was completed, detectives moved in and placed four subjects under arrest without incident. As a result of the investigation, detectives located cocaine packaged for sale, marijuana packaged for sale, a digital scale and other various items utilized as drug paraphernalia.

Glover was also wanted for a **Burglary of a Conveyance** and **Felony Battery** that occurred in January of this year.

The subjects' names and charges are as follows:

William Glover

- -Sale and possession of marijuana
- -Unlawful use of a two way communication device
- -Possession of paraphernalia
- -DWLSR

Bond: \$12,000 for narcotics charges Bond: \$27,000 for Burglary and Battery

Nicholas Bailey

- -Sale and possession of marijuana
- -Possession of drug paraphernalia
- -Unlawful use of two way communication device

Bond: \$11,000

Sammi Jo Martinez

- -Possession of cocaine w/ intent to sell
- -Possession of marijuana over 20 gr
- -Possession of paraphernalia

Bond: \$21,000

Ashley Roller

- -Principle to sale of marijuana
- -Allowing an authorized driver to operate a motor vehicle

Bond: \$3,000

The Office of Sheriff:

The Office of the Sheriff is established by the Florida Constitution.
