Re: Reverse Sting Nets Twenty-three Arrests

The Hernando County Vice and Narcotic Section conducted a covert operation on Twigg St. just south of Martin Luther King Jr. Blvd. in Brooksville. Suspects were arrested when they attempted to solicit or conspired to purchase crack cocaine from undercover detectives who were posing as narcotic dealers.
