Re: Armed Robbery - CVS Pharmacy - Spring Hill Drive

Date: November 2, 2018

On 11-02-18 at approximately 4:43 a.m., Hernando County deputies responded to reports of an Armed Robbery at the CVS, located at 11115 Spring Hill Drive in Spring Hill.

Upon arrival, deputies made contact with the pharmacist, who had just been robbed. The pharmacist advised that a white male wearing a black shirt, tan jacket, and a gray hat approached the pharmacy counter advising her that he had a weapon, then demanded specific narcotics.

The pharmacist obtained the narcotics and handed them over to the suspect. The suspect then left the store on foot.

The pharmacist contacted 9-1-1 to report the Robbery.

The night manager, who was also working at the time, was outside the store emptying trash at the time of the robbery. The night manager observed the male go into the store (assuming he was a customer) and then leave a short time later. The night manager provided the same description of the suspect, adding that he had on blue jeans and the hat was a beanie type hat.

The suspect was last seen on foot, headed to Mariner Boulevard.

Deputies arrived quickly and established a perimeter. A K-9 team responded to the area in an attempt to locate the suspect, meeting with negative results.

The investigation is active at this time. When additional details and/or a photo of the suspect are available, an update will be sent.
