Re: UPDATE - Man Convicted of Attempted Felony Murder, Other Charges

Date: October 3, 2018

Update – On 11-05-18, **Lee Roy Rettley B/M 2-13-1964** was sentenced to LIFE IN PRISON, WITHOUT PAROLE.

Original Information – 10-03-18

On 06-22-17 at approximately 11:30 a.m., Hernando County Sheriff's deputies responded to calls of a female in distress on Brook Drive in Brooksville.

Upon arrival, deputies located an injured female. The female was bleeding from her face and her shorts were torn off. The scene was secured and the injured female was transported to the hospital.

Witnesses in the area told deputies they heard the female calling for help, so they entered her residence in an attempt to render aid. Upon entry, witnesses observed a male, later identified as Lee Roy Rettley, climbing out the bedroom window.

Detectives interviewed the victim at the hospital. The victim told deputies that she had been outside earlier in the morning, had gone to a neighbor's for a short time, then returned home. While the victim was near the neighbor's residence, she observed Rettley looking at the neighbor's air conditioning vents.

Back inside her own residence, the victim observed that Rettley was also in her residence. The victim picked up her phone to call 9-1-1 and Rettley attacked her. During the extensive struggle, the victim hit Rettley in the head with a box. Rettley told the victim, "I'm going to kill you because you are going to call the cops when I leave."

During the struggle the victim continued calling for help. She was unable to scream or speak loudly, as Rettley was choking her.

When the victim's friends entered her residence, Rettley fled out the bedroom window. Before he fled out the window, Rettley stole \$900 from the top of the dresser.

Patrol deputies, detectives, and K-9 teams scoured the area, searching for Rettley. He was located, soon after the attack, hiding in a nearby storm drain.

The victim and the witnesses were shown photo packs. All parties identified Lee Roy Rettley as the attacker.

When detectives interviewed Rettley at the Hernando County Sheriff's Office, Rettley advised he "snapped." Rettley admitted to portions of the attack and to stealing the money from the dresser. He also told detectives the victim hit him in the head with something.

Detectives recovered a portion of the money from Rettley's sock.

Rettley was taken to the Hernando County Detention Center.

On 10-02-18, after a jury trial, **Lee Roy Rettley B/M 2-13-1964** was convicted of the following crimes:

- Attempted Felony Murder
- Burglary of a Dwelling with Battery
- Sexual Battery with Force – Likely to Cause Injury
- Robbery by Sudden Snatching
- False Imprisonment.

Lee Roy Rettley will be sentenced on 11-05-18.

This case highlighted the excellence of an immediate response by patrol deputies and K-9, who arrived quickly and located the suspect.

We would like to extend a special thanks to the citizens in the area who checked on the victim, likely saving her from further injury or death. Those same citizens also provided deputies with a description of the suspect and his direction of travel. This is another example of outstanding community involvement, which thwarted a violent criminal offense and brought a suspect to justice.

Additionally, we would like to recognize our partners at the Office of the State Attorney, who work so diligently to successfully prosecute cases such as this one.

The Office of Sheriff:
