Re:	Sheriff Provides Update on COVID-19

Sheriff Al Nienhuis and members of his command staff continue to monitor verified information provided by Governor DeSantis and the Florida Department of Health as it pertains to the Coronavirus (COVID-19).

Sheriff Nienhuis urges citizens to obtain any and all information on this matter from a verified and trusted source, such as the Florida Department of Health, the CDC, Emergency Management, or your health care provider. Obtaining information from sources that have not been verified could likely cause panic and/or undue stress.

Currently, there are no cases of COVID-19 in Hernando County.

The Florida Department of Health has opened a call center to assist with providing information and answering questions. The toll free number is 866-779-6121.

Everyone can help to prevent the spread of disease by following a few simple steps:

- Stay home if you are sick
- Avoid contact with people who are sick
- Get adequate sleep and eat well-balanced meals
- Wash hands often with soap and water (20 seconds or longer)
- Dry hands with a clean towel or hand dryer
- Avoid touching your face/eyes
- Cover your mouth with a tissue or sleeve when sneezing
- Clean and disinfect "high touch" surfaces often
- Call, before visiting your health care provider

The CDC has provided a list of recommended guidelines, they are as follows:

- Elderly persons with underlying health conditions should avoid cruise ships and/or any travel that is unnecessary
- A 14 day self-isolation and social distancing (avoid going out in public and close personal interactions) upon return to the United States
- Travelers (including cruises) should monitor their health and limit interactions with others for 14 days upon return If you become symptomatic, immediately self-isolate and contact your county health department or your health care provider if you need medical care

The Sheriff is the chief law enforcement and correctional officer of the county.

Sheriff Al Nienhuis was initially appointed as the Sheriff of Hernando County by the Governor in January of 2011. He was then elected by the people of Hernando County in 2012, ran unopposed in 2016, and remains accountable to them.
