**Re:** Brooksville Man Charged with Trafficking in Methamphetamine – 2022-32105

The Hernando County Sheriff's Office Vice and Narcotics Unit was recently notified of a large quantity of narcotics that was destined for a residence in Hernando County.

Subsequent investigation confirmed that approximately one pound of methamphetamine was currently at a residence in Brooksville.

Probable cause was developed for a search warrant at 7495 Mitchell Road. On 10-28-2022, a residential search warrant was executed at that location.

**Kristopher Griswold DOB/10-19-1970** was located at the residence during the execution of the search warrant and was found in possession of the following items:

- Approximately 1.01 pounds of Methamphetamine (approximate street value of \$4,000)
- Approximately 1.7 grams of Fentanyl
- Approximately 2.3 grams of Marijuana
- Approximately 1 gram of Codeine in pill form
- Drug paraphernalia to include digital scales, syringes, smoking pipes and baggies for packaging narcotics.

Griswold is a convicted felon and has prior arrests for **Possession of a Controlled Substance, Possession of Marijuana, Possession of Drug Paraphernalia, and Driving While License Suspended.**

As a result of the illegal items located during the search warrant, Griswold was placed under arrest and transported to the Hernando County Detention Center for the following offenses:

- **Trafficking in Methamphetamine (over 200 grams)**

- **Possession of Fentanyl**
- **Possession of a Controlled Substance (Codeine)**
- **Possession of Drug Paraphernalia**
- **Possession of Marijuana under 20 grams**

Griswold bond was initially set at \$122,000.

Further investigation is forthcoming.

*The Office of Sheriff:*
