Re: Three Charged in Trafficking in Fentanyl and Methamphetamine – 2024-00151854

On 5-15-2024, Hernando County Sheriff's Office Vice & Narcotics detectives arrested Keegan Addis and Heather Gillespie on multiple counts of trafficking in fentanyl and methamphetamine in Hernando County.

Detectives initiated their investigation into Addis and Gillespie earlier this year. That investigation revealed Addis and Gillespie were supplying numerous individuals with narcotics at various locations throughout the county. During the investigation, detectives were able to purchase trafficking amounts of fentanyl from both Addis and Gillespie.

Detectives were able to identify the supplier of Addis' and Gillespie's fentanyl, a suspect who resides in Pasco County. State and federal agencies were simultaneously investigating the narcotics supplier and a federal search warrant was executed at this suspect's residence. This suspect was taken into custody by federal authorities and the suspect's identity is not being released at this time due to the ongoing investigation.

Currently, Addis and Gillespie are in custody at the Hernando County Detention Center. During the course of the investigation trafficking amounts of fentanyl, along with methamphetamine and marijuana, paraphernalia, and a 2001 Jeep Grand Cherokee were seized. The total amount of fentanyl seized during the investigation was 14.4 grams, which has the potential to kill more than 7,000 people.

**Keegan Daniel Addis (DOB/01-04-1987)** was arrested and charged as follows:

- 3 Counts - Trafficking Fentanyl
- 1 Count - Possession of Methamphetamine
- 3 Counts - Possession of Paraphernalia
- 2 Counts - Possession of a Conveyance for the Purpose of Trafficking Fentanyl

- 1 Count - Possession of Marijuana under 20 grams
- Bond – None
