#### UPDATE

Detectives have located Shauna Urive DOB/07-29-2000 and the victim's stolen vehicle, in Pasco County.

Urive has been placed under arrest and charged as follows:

- 2<sup>nd</sup> Degree Murder (Domestic).

During an interview with detectives, Urive confessed to killing the victim.

The investigation continues.

#### ORIGINAL INFORMATION – 09-18-23

On 09-17-23 at approximately 3:30 p.m., Hernando County Sheriff's deputies were dispatched to a residence on Darts Street in Weeki Wachee, regarding a possible Missing Person (later referred to as the victim).

Upon arrival, deputies met with family members outside the residence in question. Family members told deputies they were contacted by a friend of one of the residents. The friend was concerned, as she had not seen the victim in several days. Family members then responded to the residence.

With assistance from family members, deputies accessed the residence via the front door. While conducting a thorough check of the residence, deputies located the victim, an adult female, in a bedroom. The victim was obviously deceased, as she was in the advanced stages of decomposition.

Deputies immediately noted suspicious circumstances surrounding the death and contacted Major Case detectives and Forensic specialists, who took over the investigation.

An autopsy will be conducted to determine the victim's cause of death.

Investigation revealed the victim's significant other, Shauna Urive W/F DOB/07-29-2000, and the victim's vehicle, a 2005 silver Pontiac Grand Am, bearing Florida tag/CG2VH, to both be missing.

Shauna Urive has been entered into FCIC/NCIC as a Missing Endangered Person, as detectives are unable to confirm her well-being at this time.

The victim's vehicle has been entered into FCIC/NCIC as a stolen vehicle.

There is no additional information available at this time. Updates will be provided when information is available.
