### UPDATE

In January 2024, **Michael Groves, DOB/10-19-1966**, was arrested and charged with possession of child pornography. This arrest preceded another investigation into Groves for multiple counts of alleged sexual abuse of minors.

The investigation resulted in obtaining evidence which yielded probable cause to arrest Groves.

On 05-01-2024, Groves was arrested and charged with 1 count of **Sexual Battery by Custodian** and 1 count of **Showing Obscene Material to a Minor**. The state attorney's office further direct filed an additional count of sexual battery by custodian as well as 1 count of attempted sexual battery by custodian.

On 05-02-2024, a grand jury hearing resulted in the indictment of Groves on all 4 aforementioned counts.

### ---Original Information - Released 01-25-2024---

On 11-18-23, Hernando County Sheriff's detectives received information regarding the possession of child pornography.

Subsequent investigation revealed a possible suspect, identified as Michael Ray Groves.

Detectives authored a search warrant for Groves' on-line accounts, which was authorized by Judge B. Bell. The search warrant was subsequently served to Groves' social media provider. The search warrant yielded the contents of Groves' account.

Upon reviewing the contents of Groves' account, detectives located 73 files of Child Sexual Abuse Material (CSAM).

On 01-24-24, detectives responded to Groves' residence, located at 6979 Corliss Road in Brooksville to speak to him.

During the interview, Groves admitted to owning the social media account in question, and to viewing and possessing the files of CSAM.

Michael Ray Groves DOB/10-19-1966 was arrested and charged as follows:

- Possession of Child Pornography (73 counts)
- Unlawful Use of Two-Way Communication Device
- No Bond.

The investigation continues.
