Re: Vice & Narcotics Search Warrant Nets 10 Drug-Related Arrests in Brooksville

Date: January 31, 2025

On 01-30-2025, the Hernando County Sheriff's Office Vice and Narcotics Unit, with the assistance of the HCSO and Citrus County Sheriff's Office SWAT teams, executed simultaneous search warrants at two adjoining properties owned by the same family in Brooksville. The targeted locations included three addresses: 9135, 9155, and 9165 Carter Road.

As a result of the operation, a total of **nine individuals** were arrested onsite, with an additional subject, **Chylse Garrett**, taken into custody by the Special Investigations Unit (SIU) following the execution of the search warrants.

Seized Evidence:

During the operation, the following contraband was recovered:

- **Narcotics:**
 - **Fentanyl: 62.4 grams**
 - **Methamphetamine: 31.1 grams**
 - **Marijuana: 0.4 grams**
 - **Buprenorphine Naloxone: 2 doses/patches**
 - **Doxycycline: 11 doses/pills**
 - **Hydroxyzine Pamoate: 76 doses/pills (total weight: 15.7 grams)**
 - **Gabapentin: 16 doses/pills**

- **Weapons and Ammunition:**
 - **Firearm: 1**
 - **Ammunition: 354 individual rounds (miscellaneous) plus one box of .410 shells**

Sheriff Al Nienhuis said, “This operation is yet another example of our commitment to keeping dangerous drugs out of our community and firearms out of the hands of convicted felons. The successful execution of these search warrants, in coordination with our regional partners, underscores the importance of a proactive and intelligence-driven approach to law enforcement.”

The Hernando County Sheriff’s Office remains dedicated to disrupting illegal drug activity and ensuring the safety of our residents.
