**Re:** Three Arrested Following Traffic Stop in Brooksville – 2025-00243262

**Date:** July 3, 2025

On 07-01-2025 at approximately 11 p.m., a Hernando County Sheriff's deputy was on proactive patrol in the area of Croom Road in Brooksville when he observed a driver operating a vehicle with an expired tag.

Sgt. R. Desmond conducted a traffic stop at the intersection of N. Broad Street and Fort Dade Avenue.

As the vehicle was coming to a stop, Sgt. Desmond observed the passenger, in the rear passenger's side seat, later identified as **Megan Lee DOB/10-04-2000**, drop a pink bag out of the vehicle. As Sgt. Desmond approached the vehicle, he observed the front seat passenger, later identified as **Shawn Sellers DOB/05-02-1986**, attempting to conceal an item with his hands.

After Sgt. Desmond obtained the driver's information, he walked around to the passenger's side of the vehicle to check on the pink bag that had been dropped previously out of the open window. As he was walking around the vehicle, he observed a second bag being tossed by Sellers from the vehicle.

Once backup arrived on scene, all the subjects were removed from the vehicle.

Upon searching the pink bag, deputies located two cut straws that tested positive for fentanyl. The green bag contained 47.1 grams of fentanyl, 40.7 grams of methamphetamine, 12.6 grams of crack cocaine, 1.5 grams of marijuana, and various items of paraphernalia.

In all, three suspects were arrested at the scene.

Shawn Sellers was arrested on charges of Trafficking in Fentanyl, Trafficking in Methamphetamine, Possession of Crack Cocaine with Intent to Sell, Possession of Marijuana, and Possession of Paraphernalia. He was transported to the Hernando County Detention Center, where he is being held without bond.

Lee was arrested on a charge of **Possession of Paraphernalia**. She was transported to the Hernando County Detention Center, where she is being held in lieu of a \$1,000 bond.

A third passenger, **Victoria Beckett DOB/04-22-1994**, was arrested on an active Hernando County warrant. She was transported to the Hernando County Detention Center, where she is being held without bond.
